


MUSEUM




Along with his passengers, he also carried mail. Eventually he remodeled and added on to it, then it became the Anibal Hotel. Later becoming the Tower Hotel.



**ATHLETIC NOTES

The high school name was not used because the team was not formed under the auspices of the school. The boys elected a committee to secure the St. Francis church court. Officers were elected, Robert Morrison was elected manager, Richard Goodney captain, and George Culver treasurer.


The first game was lost to Wells on account of insufficient practice. The second was lost on account of the opponents, the Goobers of Gloversville, being a faster and stronger team. The third game with Celtics of Gloversville was won by a score of 46 - 23. This shows the team is getting better. Thursday, they will meet the Ramblers of Gloversville. It is hoped this game will be another victory.

After this game the team must be broken up. Some one not belonging to the squad, damaged the church property and now the door is locked to all the boys. If the High School had a gymnasium and under high school supervision this would not have happened, and it would have a flourishing basketball team of which the school would be proud.
